Following welcoming remarks for those in attendance, the previous meeting minutes were reviewed and accepted. We proceeded to review the latest developments since our last Chapter Meeting which was held on July 9, 2025.

 - Current status of bank account as of October 31, 2025 will be \$2,043.41.

 - Nicholas had inquired if there were any criteria for recipients for the bursaries and it was confirmed by Missy and Shane that there were agreed upon criteria submitted at the time of submitting donations.

- Missy mentioned that she would still look into the donation of the Dream Big video at the Timmins Library.
- Missy to follow up with Nicole at Northern College regarding the Open House and having an OACETT presentation for the students.
- Shane made a comment about the potential title and name change which was previously voted in agreeance within the OACETT members.
 - Rob stated that he recalls other provinces are still to vote even though it was voted in favour for our province.
 - o Shane made note that Alberta and B.C. used the P.Tech. designation.
